# Snapshot of Advice Service

## June 2021 – December 2022

In June 2021, ERCS launched Scotland's only free legal advice service in environmental and related planning law.

Our aim is to assist everyone, especially those who face the biggest barriers, to exercise their rights and hold public authorities and polluters to account on the environment.

This is a snapshot of enquiries to the advice service during its first eighteen months: between **1 June 2021 and 31 December 2022**.

# **Number of enquiries**

We want to increase awareness and confidence in exercising environmental rights. We offer free advice to individuals, community groups and organisations on environmental and related planning law.



#### **Our advice service**

You can contact us if you are seeking specific advice on an environmental issue or a general enquiry. For example a worrying planning application or loss of greenspace in your neighbourhood. It could also be if you have a general question about environmental or related planning law, such as your rights to environmental information.



# **SIMD** rank of enquiries

The Scottish Index of Multiple Deprivation (SIMD) is a relative measure of deprivation across 6,976 small areas. This was recorded for 84 of the 150 enquiries.
