In review



WELCOME FROM ERCS

On the 6th September 2023 we welcomed over 130 people from across Scotland to our first Environmental Rights Summit in Edinburgh to demand environmental justice. We hoped to create a space for everyone to learn from each other and create new friends and allies to achieve our vision:

A Scotland where every person's right to a healthy environment is respected, protected and fulfilled.

At ERCS, we talk about facing the triple planetary crisis of climate breakdown, biodiversity loss and the pervasive pollution of our air, land and water. Since our formation in 2020, we have been working hard to tackle substantive environmental problems. Many people in Scotland, particularly living in areas of highest deprivation, suffer from pollution, environmental degradation, close proximity to derelict and contaminated land, poor environmental quality, and poor access to nature-rich and multifunctional greenspace. This contributes to health inequalities and systemic discrimination. There are also procedural problems in using the law which is complicated, intimidating and unaffordable.

Our work in raising awareness of our rights, providing free legal advice, advocating for reform and, as a last resort, taking strategic public interest litigation aims to tackle these problems head on.




An enforceable right to a healthy environment
