In June 2021, ERCS launched Scotland's only free legal advice service in environmental and related planning law.

Our aim is to assist everyone, especially those who face the biggest barriers, to exercise their rights and hold public authorities and polluters to account on the environment.



SIMD rank of enquiries

The Scottish Index of Multiple Deprivation (SIMD) is a relative measure of deprivation across 6,976 small areas. This was recorded for 149 of the 250 enquiries. It was not recorded for enquiries from organisations.



- 1-20% most deprived areas
- 21-40% most deprived areas
- 40-60% most deprived areas
- 21-40% least deprived areas
- 1-20% least deprived areas
